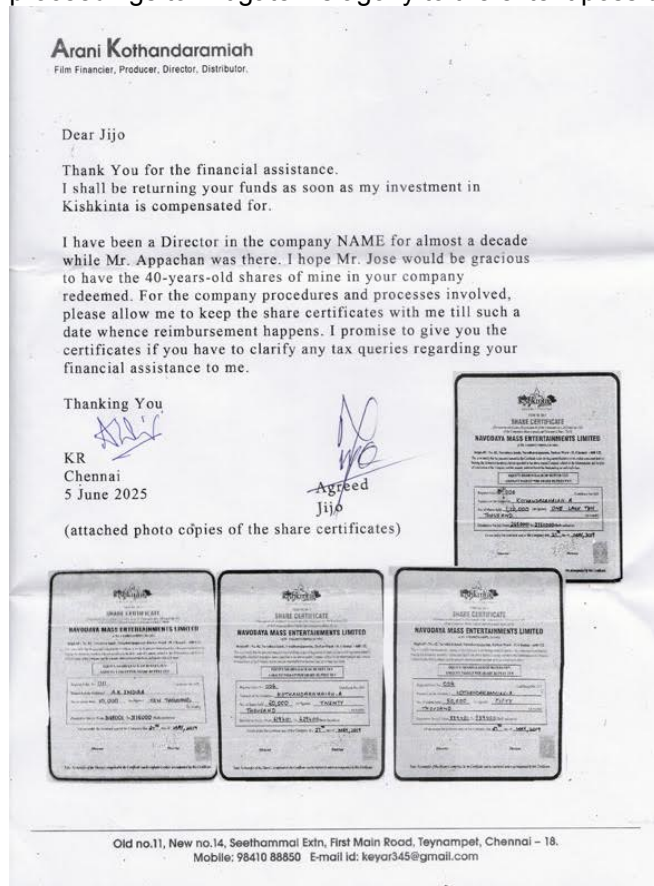

Only Joyichan (George Joseph) - a resident in my IT neighborhood, Kakkanaad - came down to offer sympathies. Like me, he himself was dispossessed of his inheritance - which he had forgave.

Yet, I am gratified by an eschatological truth.

According to the scriptures, a 'sign for the end of times' is in people becoming selfish & self-centred. [2 Timothy 3:1&2 . 2 Peter 3:3]. In the almost-total non-responsiveness to my email, the scriptural passages have come to fulfilment, ... almost. I hope it would hence be a short wait for **The Day of The Lord**.
